NARRATIVE

Narrative of Offense Committed

On or about the above stated date and time, the Defendant did having malice aforethought, kill another person, while participating in a forcible felony, to wit: Robbery 1st Degree.

AFFIDAVIT

STATE OF IOWA, JOHNSON COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 2-12-2021, at 1953 hours, the Johnson County Joint Emergency Communications Center received a 911 call reporting that a male had been shot and killed at 615 S Governor St #6 in Iowa City, IA, during a robbery by multiple persons. Officers arrived on scene and located the victim inside apartment #6. The victim was identified as Quincy Russom. The Johnson County Medical Examiner's Office ruled Russom's death a homicide.

The Defendant was identified as being in the residence at 615 S. Governor when Russom was shot. Further evidence indicated that the homicide had actually occurred more than thirty minutes prior to the 911 call being made.

The defendant was located within hours of the 911 call on the property of 615 S Governor St. and was stopped by officers. The defendant was found to have items belonging to the victim in his possession including the victim's phone. Crime lab analysis of a spent shell casing from the homicide location indicates that the shell casing was fired from a firearm found on the defendant at the time he was located at the crime scene address on 02-12-2021.
