Iowa City Telecommunications Commission October 5, 2020 – 5:30 P.M. Via the Zoom remote meeting platform

<u>Call to Order:</u> Meeting called to order at 5:35 P.M.

Approval of Minutes:

Stockman moved and Reyes seconded a motion to approve the June 29, 2020 minutes as presented. The motion passed unanimously.

Announcements of Commissioners:

None.

Short Public Announcements:

None.

Election of Officers:

All commissioners present agreed to elect Adam Stockman to be the chair of the Telecommunications Commission and Gina Reyes to be the vice-chair.

Cable TV Office Report:

Coleman said he hadn't reported on the activities of the Cable TV Office in recent months due to the Commission's shift in focus towards municipal broadband. He noted the list of video programs Cable TV staff had produced over the past six months, as found in the meeting packet, and said he was proud of all the work his team had done in response to the COVID-19 pandemic, which has included many episodes of the Mayor's Community Connection program and live-streamed updates from the Johnson County Department of Public Health.

Council request for information regarding broadband affordability and access:

Stockman said that the City Council had focused in on some of the work that Reyes had done regarding opportunities for grants and other funding. He noted that the funding included in the report was no longer available by the time the group's report was ready for submitting to Council.

Pierce agreed that the focus was on promoting affordability rather than expanding availability beyond the three primary providers that lowa City would have. He said that when he was a part of the Telecommunications Commission in the past, he was in favor of exploring public broadband, but that with the

current status of providers, it makes sense to shift the focus to affordability.

Reyes said one of the Council's comments mentioned bridging the digital divide and that just because you have a cable outside your house, it doesn't mean you have access to service. Stockman said the group should pull together any information they can find on available grants. He said that since it had been a while since the report had been completed, it would be worth looking at the funding opportunities presented within the report, but also looking for more. He noted that over the past several months, many people have had to move to remote solutions for work and school, but that not everyone has access to do so.

Stockman suggested the Commission work to see what opportunities exist and develop a simple list for the Council that includes what the funding potential is and links to the relevant information or applications. Reyes said it would be helpful for each person to see what they can come up with, noting that the group may find some of the same opportunities, but that together they could cast a wider net and potentially identify more options. Members of the Commission agreed that they would each research potential funding opportunities and report back at the next meeting.

Adjournment:

Stockman moved and Reyes seconded a motion to adjourn. The motion passed unanimously. Adjournment was at 5:49 p.m.

Program Overview

The federal universal service high-cost program is designed to ensure that consumers in rural, insular, and high-cost areas have access to modern communications networks capable of providing voice and broadband service, both fixed and mobile, at rates that are reasonably comparable to those in urban areas. The program fulfills this universal service goal by allowing eligible carriers who serve these areas to recover some of their costs from the federal Universal Service Fund.

Telecommunications Commission Report on Broadband Grant Opportunities

Presented by Adam Stockman, Gina Reyes, Andrew Austin, and James Pierce

In August of 2020, City Council reviewed municipal broadband research that had been compiled by the Telecommunications Commission. At that time, it was decided that pursuing municipal broadband in lowa City was not something City Council felt was appropriate. However, City Council was interesting in hearing more information about possible grant and funding opportunities that could help close the digital divide and improve access to, and affordability of, broadband internet access.

The ongoing pandemic and the associated dramatic increase of remote working arrangements and remote education has made it clear that access to broadband internet is not a luxury, but a necessity.

The availability of grants designed to improved accessibility and affordability of broadband is dynamic.

At the time of this report, the most promising opportunities appear to be:

- Iowa's Office of the Chief Information Officer https://ocio.iowa.gov/broadband-grants these opportunities are geared towards expanding access to broadband in rural areas, which could be useful as Iowa City continues to expand.
- The NTIA (National Telecommunications and Information Administration) had previously administered large grants. Their role has now changed to promote digital inclusion. Recommended Dissolution Telecommunications Commission Presented by Adam Stockman, Gina Reyes, Andrew Austin, and James Pierce

Since the expiration of Iowa City's franchise agreement with Mediacom in August of 2018, the Telecommunications Commission has functioned without a clear charge. Preliminary data gathering to determine the feasibility of pursuing municipal broadband provided a clear task for the Commission and subsequent investigation into funding opportunities to improve accessibility and affordability of broadband gave the Commission purpose.

Members of the Telecommunications Commission are committed to serving lowa City and have thoroughly enjoyed working on the projects mentioned above. However, unless a new charge is given to the Commission, we recommend dissolution of the Telecommunications Commission.
